Terms and Conditions

These Terms and Conditions apply to all clubs receiving a £500 grant (the "Grant") under the Disability Cricket Champion Club Fund 2021 (the "Scheme") and should be read in conjunction with the attached Guidance Notes. These Terms and Conditions, the application form and the Guidance Notes together form the agreement between the ECB and the club named in the application form (the "Club") ("the Agreement").

By submitting an application form in respect of the Scheme, the Club agrees, if awarded a Grant, to comply with the terms of this Agreement.

1. Representations and Warranties:

The Club represents, warrants and undertakes:

- a. that the declarations made in its application form are true and accurate to the best of its knowledge and belief;
- b. it has full capacity and authority to enter into this Agreement;
- c. it is not aware of any circumstances which would prevent it from fulfilling its obligations under this Agreement;
- d. if there are any changes to the Club's circumstances which could affect its eligibility or suitability for the Grant or its ability to fulfil its obligations under this Agreement, it will notify the ECB in writing without delay;
- it will at all times comply with all applicable legislation in the performance of its obligations under this Agreement;
- f. it has obtained and will maintain and comply with any permits, licences, permissions, consents, approvals, certificates and authorisations which are required for the performance of its obligations under this Agreement;
- g. that it will spend the Grant on Approved Grant Activities (as defined in the Guidance Notes) as set out in the Club's application form;
- h. that it complies and will continue to comply with all the criteria for the award of the Grant as set out in the Guidance Notes.

2. Claim Form and Payment Process

- a. The Club agrees that it shall submit a Claim Form and supporting documents to the ECB in accordance with the instructions provided in the Guidance Notes and on the Claim Form itself.
- b. Following receipt of a Claim Form which complies with a. above, the Grant will be paid in a single payment in arrears directly to the Club's nominated bank account via BACS transfer by the ECB, subject to the necessary funds being available when the payment falls due. The Club agrees and accepts that payment of the Grant can only be made to the extent that the funds are available.
- c. Any failure by the Club to submit a Claim Form in accordance with the instructions and by the specified deadline (including the provision of any supporting documents necessary to enable the claim to be processed) may result in payment of the Grant being delayed, reduced or withheld.
- d. The amount of the Grant shall not be increased in the event of any overspend by the Club in the delivery of its obligations under this Agreement.
- e. If the Club breaches any term of this Agreement or if there is a change in circumstances affecting its eligibility to receive the Grant, the ECB reserves the right to withhold or require repayment of the Grant.
- f. If the Club receives any overpayment or any payment to which it is not entitled (including in the event of an administrative error), the undue amount must be repaid. It is the Club's responsibility to check all payments it receives from the ECB and notify the ECB immediately if it has any reason to believe that an error has occurred.
- g. The Club and the ECB acknowledge that due to the ongoing COVID-19 pandemic, the Club may be prevented from undertaking Approved Grant Activities in 2021. In such circumstances, the Club must notify the ECB without delay and the Agreement shall be deemed to be void ab initio and, for the avoidance of doubt, the ECB will not be required to pay the whole or any part of the Grant to the Club. Provided the Club continues to meet the relevant eligibility criteria, the Club shall be permitted to resubmit an application form for the 2022 Scheme (if applicable).

3. Acknowledgement and Publicity

- a. The Club shall comply with all reasonable instructions and guidance from the ECB in relation to acknowledgement and publicity of the Grant.
- b. The Club shall comply with all reasonable requests from the ECB to facilitate visits, provide reports, statistics, photographs and case studies that will assist them with any promotional and publicity activities relating to the Scheme.

4. General

- a. To the extent permitted by applicable law, the ECB shall not be liable to the Club or any third party for any damage, injury or loss of any kind whatsoever that arise directly or indirectly from the activities undertaken in connection with this Grant or the use of the Grant by the Club.
- b. The ECB's total aggregate liability in connection with this Agreement shall not exceed the amount of the Grant.
- c. Nothing in this Agreement shall limit or exclude the ECB's liability for death or personal injury resulting from negligence or any liability for fraud or fraudulent misrepresentation.

d. This Agreement and any dispute or claim arising out of or in connection with it (including non-contractual disputes or claims) shall be governed by and construed in accordance with English law and the parties irrevocably submit to the exclusive jurisdiction of the English courts.

Guidance Notes

1. <u>Aim</u>

The Scheme aims to support Clubs to provide regular cricket opportunities for disabled individuals.

2. Eligibility

In order to apply for a Grant under the Scheme, Clubs will need the following:

- To be affiliated to ECB via their County Cricket Board (CCB) in 2021
- A Constitution
- Valid Buildings, Contents & Public Liability Insurance
- Security of Tenure Leasehold, Freehold or Rental Agreement (minimum of one year)

3. Approved Grant Activities

If awarded a Grant, Clubs will be able to spend the Grant in one or more of the following areas in respect of the 2021 cricket season only ("Approved Grant Activities"):

- Additional equipment Grant can be used to purchase additional equipment that assists with making the game more accessible.
- Coaching Grant can be spent on paying a coach to support with the delivery of disability cricket sessions; however,
 there must be at least one coach engaged in each disability cricket session from the host Club, to promote
 integration within the Club set-up, as well as increasing the confidence of the coaching workforce and sustainability
 of disability cricket within the Club.
- **Promotion** Grant can be spent on the promotion of disability cricket sessions at the Club through physical and digital assets and taster sessions.

The ECB recognises that due to the ongoing COVID-19 pandemic, the Club may be prevented from undertaking Approved Grant Activities in 2021. In such circumstances, the Club must notify the ECB without delay and the Agreement (including the application form) will be deemed to be void ab initio and, for the avoidance of doubt, the ECB will not be required to pay the whole or any part of the Grant to the Club. Provided it continues to comply with the eligibility criteria, the Club will be permitted to resubmit an application form for the 2022 Scheme (if applicable).

4. Amount of Grant

£500 per Club.

6. <u>Scheme criteria</u>

- 6.1 In 2021, the ECB will provide Grants to up to 120 Clubs across England and Wales. Once this number has been reached, no further grant funding will be available in 2021 under the Scheme. However, Clubs interested in supporting disability cricket activity will still be encouraged to access support and resources through the ECB website and from their local CCB, and to submit an application for grant funding under the 2022 Scheme (if applicable) or similar funding schemes in the next calendar year.
- 6.2 Within the application form Clubs must give a 'Brief Programme Description'. Clubs must demonstrate in their application form how the Grant would allow them to:

- introduce disabled people to cricket at their Club and/or increase the frequency that disabled people play cricket at their Club:
- improve the cricket experience for disabled people at their Club.
- 6.3 This is a new ECB scheme for 2021 and as such any club who has previously supported disability cricket activity can submit an application form under the Scheme and would be encouraged to do so. Historical delivery and any links with external disability support providers should be detailed within the Programme Description on the application form.
- 6.4 Please note that Clubs will be entitled to receive a Grant under the Scheme once. Accordingly, any Club who is awarded a Grant under the Scheme will not be permitted to receive grant funding under the Scheme in subsequent years.
- 6.5 All application forms will be reviewed by the ECB Disability Cricket team to be assessed against the Scheme Criteria set out above and consideration will be given to ensuring a reasonable geographic spread of supported Clubs across England and Wales.

7. Application Process

- 7.1 Clubs interested in receiving a Grant under the Scheme must submit a completed application form accessible from https://www.ecb.co.uk/play/open-age/disability-cricket/championclubs
 Completed application forms must be emailed to disabilitycricket@ecb.co.uk within the timeframe detailed below.
- 7.2 Application forms must be submitted between Monday 25th January 2021 and Friday 30th April 2021. Application forms received after Friday 30th April 2021 will not be considered.
- 7.3 ECB will aim to respond to all application forms within 1 month of receipt and by no later than Friday 4th June 2021. Application forms will be assessed against the Scheme criteria as and when application forms are received by the ECB.
- 7.4 If an application form cannot be supported under the Scheme, the Club will be notified and, where possible, given guidance and assistance to engage with the Scheme or a similar scheme in subsequent years.

8. <u>If an Application is Successful</u>

- 8.1 ECB will notify the Club (by email to the "Main Contact" email address provided on the application form) if their application form has been successful.
- 8.2 If successful, a Claim Form will be issued (by email to the "Main Contact" email address provided on the application form) to the Club and the kit bag will be distributed to the Club's nominated delivery address as set out in the application form.
- All completed Claim Forms must be submitted to ECB, together with reasonable evidence that the Approved Grant Activities have been delivered including (as applicable) that (a) disability cricket sessions have taken place (such evidence to include, without limitation, number of attendees/participation figures and dates of sessions), and/or (b) proof of purchase of any equipment designed to make cricket more accessible, and/or (c) proof of expenditure incurred in the promotion of the disability cricket sessions, by Friday 26th November 2021.
- 8.4 The Grant will be paid in a single payment in arrears directly to the Club's nominated bank account via BACS transfer, within 30 days of receipt of a completed Claim Form which complies with paragraph 8.3 above.
