WHO ARE WE?



The DCF is a registered charity that improves lives and empowers communities across Derbyshire through cricket. We also serve as the governing body for recreational cricket in Derbyshire – one of 39 county organisations working with the England & Wales Cricket Board (ECB) to support a network of grassroots clubs and leagues to develop and sustain the game.

ABOUT THE DERBYSHIRE CRICKET FOUNDATION

The core game is thriving in Derbyshire. More cricket will be played in Derbyshire this year than in any recent year, thanks to a strong network of committed volunteers in 105 grassroots clubs and several leagues across the county. Participation among Women & Girls is growing rapidly, and cricket is one of the few sports with more children now playing regularly than prior to the Covid-19 pandemic. We deliver cricket in over 100 primary schools across the county, and provide pathways for those children inspired to continue playing the game. We support grassroots clubs to develop the facilities and volunteer workforce needed to support growth and create safe, welcoming environments for a more diverse audience.

Different formats of cricket enable us to include those who have historically "missed out" on cricket and physical activity. We provide opportunities for people to play table cricket, street cricket, soft-ball and walking cricket, and we enable those with a disability or long-term health condition to access activity and new communities. We make cricket more accessible by taking action to reduce financial barriers and by taking it into local schools, parks, sports halls, and play areas across the county. We are excited by the impact we have delivered, and recognise there is still opportunity to do more.

The DCF is fortunate to have an excellent and committed team, with 18 permanent members of staff, and a supplemental group of part-time qualified cricket coaches who support delivery of our programmes. We are contracted to deliver activity and meet quality standards by the ECB and their charity partners, who regard us as a high performing delivery partner. Our annual income has doubled to around £900,000 in the last five years, enabling us to deliver more programmes and impact across the county. We have further opportunities to grow our income and impact in the next five years, and diversifying our income streams to include more funding from charities and business partners is a key priority.

THE ROLE OF A DCF TRUSTEE

We are recruiting several new voluntary trustees to help provide the strategic oversight and non-executive Board-level governance to support delivery of our ambitious strategy. Adding new and diverse skills and experience and Trustees who can provide different perspectives and constructive challenge will help us become the high-performing Board that cricket in Derbyshire deserves. As a DCF Trustee you share ultimate responsibility for governing a charity and directing how it is managed and run, but the roles are largely "eyes-on, hands-off", as our staff members manage the day-to-day operational business of the DCF. We are seeking to appoint Trustees who can make a wide contribution to the oversight of the overall business, as well as bring some specific relevant skills and experience. A deep knowledge of cricket is not essential, but we are seeking Trustees who care about cricket or sport as a vehicle to improve lives. We are particularly keen to attract applicants who can add the following skills and experience to our Board.

- Finance Director who will also Chair our Audit Committee
- Charitable Fund-Raising
- Business Development
- Safeguarding

Trustees are initially appointed for a 3 year term, with an option to serve a further two terms, up to a maximum of 9 years. A comprehensive induction will be provided for new Trustees, to ensure they have good understanding of the DCF business.

WHAT TIME COMMITMENT IS INVOLVED?

We have 6 Board meetings a year, typically of 2.5 hours duration. Board papers are issued the week before the meeting, and Trustees are expected to have read the papers in advance of the meeting in order to maximise opportunities for dialogue and input at the meeting. Board meetings are on midweek evenings, and start at 5.30pm, and are typically hosted at the Derbyshire CCC Central Co-Op County Ground in Derby. All our Board meetings have a hybrid format, so that Trustees can attend remotely via Teams if they need that flexibility.

Trustees are also expected to be a member of one of our Board committees which will be aligned with their areas of interest or experience, and which will typically involve attending a further one or two meetings a year. There may be further occasional opportunities for Trustees to assist or support our work, but we appreciate that the role is a voluntary commitment and respect that our Trustees will need to balance their time with other commitments important to them.

THE RECRUITMENT PROCESS

Shortlisted candidates will be invited to interview during weeks commencing 3rd November and 10th November. Appointments will be confirmed by the end of November, and new Trustees will be provided with an induction during December prior to joining the DCF Board at the start of 2026.
